Now is the time to make your reservations. Come meet your CORY COUSINS and board members, share stories, genealogy, hints for researching and visit a desirable vacation spot. The Best Western Lighthouse Lodge is located one block from the Pacific Ocean at the corner of Lighthouse Ave. and Asilomar Blvd. Included in the room price: a complimentary continental breakfast, social hour 4:30pm - 6:00pm and weather permitting an outdoor barbecue cookout.

Pacific Grove was first settled in 1775 as a Methodist Camp Meeting Ground complete with muddy tent sites. These were replaced with Cottages and later many magnificent Victorian mansions were built. In 1879 Pacific Grove was designated as the second Chautauqua Center in the United States. Just what was the Chautauqua Movement? My guess is that we will find out in June. You will have the opportunity to attend services at the First United Methodist Church.

1997 REVIEWING OUR CORY ORIGINS IN ENGLAND

No trace of our **THOMAS** CORY of Chelmsford, MA has been found in England, not even a suspicion. The problem is that we have no information as to his date or place of birth or the names of his parents.

The baptism record of WILLIAM CORY of Portsmouth, Rhode Island has been found in the records of St James Church in Bristol, England, along with his father John's baptism and his paternal grandparents John and Ann (Wauker) Cory marriage record. The Cory name is found in Bristol records dating back to the fourteenth century.

However two of our most fervently held theories have recently been disproved. First, the **ROBERT** CORIE of Bramerton Hall, Norfolk IS NOT connected to the Scottish Robert de Corrie family. Old records compiled by Peter le Neve, Norrey Kings at arms and proved in Chancery (court) about 1745 state that Robert Corrie immigrated from Cornwall in 1398. No English Cory family has been found to have descended from the Scottish Robert de Corrie line. No American Cory has been found to have descended from the Bramerton Hall Cory family.

Second, it has been a long held belief that JOHN CORY (COREY) of Southold, NY was descended from the Bramerton Hall Cory family. The Peter le Neve records eliminate all possibilities of this relationship. There are several other possible lines but to date no proof as to the names of John's parents has been found.

GILES CORY was baptized 19 Aug 1621 in St Sepulcher's Church in Northampton, England, the oldest of four children of Giles and Elizabeth Cory.

Giles probably arrived in Massachusetts between 1640 and 1644. His name appears as a witness in a court case on 11 Jul 1644 while he was employed as a farm worker.

Industrious, hardworking as well as physically strong Giles eventually owned a large farm of 150 acres in what is now Peabody near Salem, MA. Even in his later years he outworked many younger men. However Giles would never be a candidate in a popularity contest. He was short-tempered, quarrelsome, and mean spirited, traits that often landed him in the courts to settle relatively minor squabbles with his neighbors.

Giles and his third wife, Martha were both arrested in the infamous 1692 witchcraft hysterics. He wrote a will 11 Jul 1692 while being held in the Ipswich jail, leaving his remaining property to his sons-in-law, William Cleaves and John Moulton. He had earlier given his other daughters and husbands their portions of his estates.

Giles refused to plead either guilty or not guilty. Under British law he was 'pressed' to encourage him to cooperate. This cruel form of 'persuasion' involved staking him on the ground, placing a large board on his chest, and piling large rocks on top until he provided information or died. Giles survived three agonizing days of this torture before he died on 19 Sep 1692. Martha was hung on Gallows Hill 22 Sep 1692. Eighteen other men and women suffered the same fate.



Two other English laws effected the outcome of that tragic affair. A suspect could not be brought to trail without pleading either guilty of not guilty and if convicted of witchcraft would have all their property confiscated and sold. However this crusty, contentious curmudgeon did not suffer in vain as his property was not confiscated. I think it can be said that he won the last battle

Most of the young girls (children) who were the accusers later publicly recanted their stories.

Twenty years later the Massachusetts Legislature annulled the convictions and made some reparations to the families, including those of Giles who received twenty one pounds.

Thomas Rich, the son of Martha Cory and Henry Rich, her first husband also received a settlement of fifty pounds. This Thomas possibly accounts for Giles being suggested as the father of Thomas Cory of Chelmsford, MA.

FERNVILLE - FIFTEENTH CINTURY CORY HOME IN HARPOLE, ENGLAND

Five miles west of Northampton, in the village of Harpole, there has been a continuous succession of Cory descendants since the fifteenth century. In 1435 an unnamed Cory built a large home to which various additions have been made through out the centuries. There is an old deed dated 1485 conveying the Harpole property to a Nicholas Cory. This deed inscribed on pig skin, is still in existence.

Fernville had been in and out of Cory ownership numerous times. Arthur and Mary (Billingham) Cory, the grandparents of Colin and Brenda (Cory) Miller were the last Cory owners. Following the death of Mary Cory in 1968 Fernville was sold out of the Cory family. Brenda Miller says her father, Fred Cory, his two brothers and one sister all grew up at Fernville.

Fernville has its own resident friendly ghost who roams the house calling "Mary". The present owners report having heard the ghost recently.

The Northampton, England material on both Giles Cory and the Fernville house was contributed by Brenda Miller. She and her Brother Colin have done extensive research into the old records of Northampton and surrounding villages gathering Cory data.
