JOHN I of Southold

1. ¹ CORY John I. Born, 9 Oct 1611 (??) in Bramerton Hall, Norwich ENG. Died, 7 Mar 1684/5, in Southold, Suffolk Co LI NY. Occupation: Weaver. Just where John I came from in the old world as of now, can not be proven satisfactory strong enough to say at this time. It is believed he came to America somewhere near 1637. He may have lived in Salem Massachusetts and Rhode Island prior to going to Long Island, NY. We believe that John was one of the men who assisted John Youngs on October 21 1640, in the organization of the first (Presbyterian) church at Southold L.I. NY.. John Cory is mentioned as of being from Southold and as the Whale Commissioner 7 March 1644.. The WILL of John CORY I, dated 1 February 1685. Proved 2 October 1685.. I give to Son John , Iorn Kettle, Great Bible, Chest and its contents, a Cloke and 1/2 a debt of 12 lbs, half my Weaving Takell, my Bell Mette Skillet, Beds Rugs and Bolsters..I give my son Jacob halfe my Land in Ye Oyster ponds, Upper Neck, to be paid by son Abraham, 2 Cows, halfe my Sheep, Weaving Cloaths and halfe my Weaving Takell, half my Husbandry Tools, with halfe my Lumber and 14 acres of Land to his son..To son Abraham my lot in Ye Oyster Ponds, upper Neck, he paying halfe ye price to his brother Isaac, halfe my Sheep, 1/2 a debt of 12 lbs, halfe my Husbandry Tools and 1/2 lumber.. Abraham my son to pay all my debts and to pay his brother Isaac 5 Shillings and to satisfy William Tuthill for what trouble he is at about, my will.. To Daughter Hannah Lot by Bill and her Daughter Hannah an Iorn pot and one Heifor.. Daughter Abigail an Iorn pot, 1 Iorn Kettle, Blankets and pillows, a chest and whats in it.

He married SALMON Ann, daughter of SALMAN William, 2 Jul 1638, in NEW LONDON CT. Born, 25 Feb 1616/7, in St. Botolph's, London ENG. Died, 17 Jan 1680/1, in Southold, Suffolk Co LI NY. Children:

- i. John II. Born, 1639, in Southold, Suffolk Co LI NY. Died, 1 Jan 1685/6, in Huntington, Suffolk Co LI NY. Occupation: Farmer/Merchant. He married CORNISH Mary, daughter of CORNISH Thomas and STONE Mary, 15 Dec 1667, in Stamford CT. John removed to Huntington, L.I. about 1660. On July 7, 1663 he bought a lot at Huntington for a home. Was granted land there in 1668, 1681 and 1682. He was at one time one of the owners of number nine of ten farms. He is said to be a Quaker, a man of considerable importance in Huntington, being town clerk, arbitrator, recorder, etc. His Will dated 25 January 1686 was never proven. Inventory of his personal property was 82 lbs 10 shillings. Witnesses Joseph Whitman and James Chechester. His widow Mary Cornish married John Sammis. Mary survived both her husbands, she was mentioned by her son John on 9 April 1696 as then living.
- ii. Sarah. Born, 1640 (?), in Southold, Suffolk Co LI NY. Died, 1700 (?). She married WILLIAMS Nathaniel (Son of Richard Williams).
- iii. Abraham (Will dated May 19 1701--Proved Oct 14 1741 Early LI wills pg 256). Born, 1641 (?), in Southold, Suffolk Co LI NY. Died, 10 Sep 1702, in Southold, Suffolk Co LI NY. He married CHRISTOPHERS Margaret (Margarets Father gave her his home in New London Ct on July 8, 1700.), daughter of CHRISTOPHERS Jeffrey, 1665 (?), in NEW HAVEN CT.
- iv. Hannah. Born, 1644, in Southold, Suffolk Co LI NY. Died, 1706, in Huntington, Suffolk Co LI NY. She married BRUSH Richard (Son of Thomas Brush), 1668 (?), in Huntington, Suffolk Co LI NY.
- v. Jacob. Born, 1646 (?), in Southold, Suffolk Co LI NY. Died, 15 Feb 1705/6, in Southold, Suffolk Co LI NY. He married TUTHILL Ann, 1672 (?). A list of Jacobs lands will be found in the town records of southold LI NY. He was Overseer, and patentee of Southold. He was worth 92 lbs in 1683, while three years later his household was composed of two males and five females. Griffin in his "Journal" names Jacob in his list of the thirteen earliest settlers of Southold.
- vi. Isaac. Born, 1649, in Southold, Suffolk Co LI NY. Died, 8 Mar 1701/2, in Southold, Suffolk Co LI NY. He married (Recorded Hss southold Town Records) LUDLAM Sarah, daughter of LUDLAM Anthony and LUDLAM Sarah, 1682, in Southold, Suffolk Co LI NY. On July 6, 1680, his father gave him a deed of trust for most of his possessions (Southold town records I, pg 115). Isaac was rated at Southampton in 1683, on 148 lbs, 3s, and 4d. In 1686, as an inhabitant of that town, he drew lot No. 50 of the Acobogue meadows, in connection with Henry Ludlam. He afterwards removed to the town of Southold, where he owned over a hundred acres in 1695. Letters of administrtion on the estate of Isaac were issued to his widow, Sarah, on May 21, 1702. (Long Island Wills)
- vii. Abigail. Born, 1650, in Southold, Suffolk Co LI NY. Died, 1686, in Huntington, Suffolk Co LI NY. She married SAMMIS John, 1672.

WILLIAM I OF TIVERTON RHODE ISLAND

1. **CORY William.** Born, 1618 (??) in Bramerton Eng. Died, 4 Jan 1681/2, in Portsmouth, Newport Co RI. William lived in Portsmouth, RI. He was a Carpenter and a Miller. December 10, 1657 He had a grant of 8 acres of land. May 18 1658 William was made a freeman. 28 Oct 1662 he let or hired out his now dwelling house, with fenced land to Peter Polger of Newport, for five years with conditions for improving farm. Dec 4, 1669 he had a deed of a third of a share in Dartmouth, from William Earle. 7 January he was a Jury man. On 4 April 1676 he and three others, were appointed to have the care and disposing of one barrel of powder for the town and two great guns that were in the yard of the late deceased William Benton. To be carried to Portsmouth and placed, one on Ferry Neck and one near house of John Borden. The above committee causing said guns to be set on carriages and fitted for service. 24 August 1676 was a member of the court martial held in Newport for the trial of certain Indians.

WILL Dated 4 January 1681. Proved 24 February 1682, To Wit: Exx. Wife Mary. Overseers, Friends William Woodell, John Sanford and George Brownell. To wife, absolutley at her disposal, all lands, etc., with my wind mill at Portsmouth, and all personel estate, whatsoever and wheresoever, except legacies. To her, for life, use of dwelling house in which I dwell (except two rooms to son William), half orchard, half the barn and use of half of all the upland and meadows, adjoining land belonging to deceased William Hall. To eldest son John, certain land in Portsmouth, with Housing, etc., for life and to such children he may will it to, but if John have no issue, he may dispose of it to his brothers and sisters of whole blood. To son William, great lower room of southerly part of dwelling house, which now at this time I inhabit, with the leanto room adjoining, commonly called Margarets room, half of orchard, profits of half upland and meadow adjoining, and at decease of my wife, his mother, he to have all rest of the lands and house for life, and to his children, if he have any. To third son Thomas, at twenty one a half share in Pocasset lands divided and undivided (a share being one thirtieth part). To fouth son Caleb, at age, a third of a share in Dartmouth, for life. To fifth son Roger, at age the other half share in Pocasset land, and if he die with out issue, his part to go to his brother Thomas. To Eldest daughter Mercy 10 lbs, to second daughter Ann, at eighteen or marriage, 10 lbs. To third daughter Mary, 10 lbs. To fourth daughter Joan 10 lbs. The children left to wifes care, to be tenderly brought up and educated.

He married **EARLE Mary.** Born, circa 1628 (?), in ENG. Died, 22 Mar 1717/8, in Portsmouth, Newport Co RI. Mary was the daughter of Ralph and Joan Earle. January 15, 1682 Mary Widow of William took receipt from eldest daughter, Mercy Cory, for legacy, and the year following took receipt from Robert Bennett and her daughter Ann. Mary recieved in writing from Joseph Timberlake, of Little Compton previous to their marriage, she was to have after marriage, full liberty to improve and dispose of all her former husbands property and estate. Mary gave full power of the estate to Edward Mory and George Brownell, for bringing up of her children, reserving only to herself a mare, four neat cattle, four hogs and four sheep. 1683 Mary married Joseph Timberlake.

Will dated 12 August 1717, Proved 14 April 1718, to Wit: Ex. Son Thomas Cory. To grandson William Cory, son of John, a piece of milled money of value of 5 or 6 sh. To daughter Mercy Gonzales, a piece of money. To son in law Charles Gonzales, five cords of wood he owes me. To daughter Sarah Jeffries, an indian girls term, named Dinah. To grandsons Michael and William Cory, brothers, each a piece of money. To grand daughters Anne and Mary Bennett daughters of daughter Anne, a piece of mild gold. To daughter Jane Taylor, use of cuboard and chest, for life and then to my grandson Samuel Chaplan. To my daughter Mary Cook, a quarter of apparel, and like legacy to daughters Jane Taylor and Sarah Jeffries. Whereas, son Thomas Cory, has money I lent him, 29 lbs, 9 lbs and 6 lbs remitted him in behalf of my son inlaw Thomas Jeffreis, which sums I lent my son inlaw Thomas Jeffries, 6 lbs, and I lent my son inlaw Roger Cook 5 lbs and I lent my son Roger Cory these sums are all to be included in rest of movable estate, and the same equally devided with the other quarter of apparel, as follows: To children of daughter Mercy, one sixth, (with quarter of apparel), to daughter Mary Cook, sons Thomas and Roger Cory, and Daughters Jane Taylor and Sarah Jeffries, each a sixth. Inventory. 167 lb 8s 11d Children:

- i. Anne. Born, circa 1650 (??) in Portsmouth, Newport Co RI. Died, circa 1700 (??). She married **BENNETT Robert** (Son of Robert and Rebecca Bennett), circa 1680 (??).
- ii. John. Born, circa 1655 (?), in Portsmouth, Newport Co RI. Died, 31 May 1712, in Portsmouth, Newport Co RI. He married **CASSETT ELIZABETH (FATHER WAS AN INDIAN CHIEF)**, circa 1678 (??). May 7, 1679 on his petition was granted by assembly, land in East Greenwich, out of shares not taken up. 1686 made a Freeman. 22 March 1686 John of Portsmouth, had 10 acres of land laid out to him in East Greenwich. 4 April 1705, Bought of Daniel Thurston and wife Mary, of Newport, 90 acres of land in East Greenwich for 40 lb. 10 April 1705 He and wife Elizabeth, sold Jonathan Nichols, of Newport 12 acres for 20 lb. 16 April 1705 He and Wife Elizabeth, sold to William Brightman, of Newport, 50 acres, for 350 Lbs. 4 October 1707 he deeded son William, for love etc 90 acres, house and meadow, at East Greenwich. (Both he and son were of Portsmouth, at this date.). 1707 Kings Town Deputy. 12 May 1712. WILL-Proved 14 July 1712. Exx. Wife Elizabeth. To Wife, certain land and all personal. To son John, house and land, he paying certain legacies. (The rest of will illegable or destroyed.). 26 June 1713 Widow Elizabeth, of Kings Town, sold John Mumford, of Newport, 91 acres in east Greenwich, for 16 lbs. 15 Dec 1713 Son Thomas, with consent of mother Elizabeth, put himself apprentice to Christopher Lindsey, of Newport, house carpenter, for the term of four years, eight months and seventeen days.

- iii. William. Born, circa 1659 (??) in Portsmouth, Newport Co RI. Died, Jun 1704, in Portsmouth, Newport Co RI. He married COOK Martha (Dau of John and Mary (Borden) Cook), 1681 (??) in Portsmouth, Newport Co RI. 1684 William was made a freeman. 1687 served on Grand Jury. July 2, 1695 He was appointed by assembly, on committee to propose a method of making tax rate. WILL Dated 14 May 1704. Proved 4 June 1704 Exx. Honored Mother and my brother inlaw, Joseph Cook. To son Michael, 12 acres, at age, and if he die without issue, to son Thomas. To second son William, all other lands, housing and orchard to me belonging, except 15 acres. To third son Thomas 5 acres. To son Michael 10 acres. To daughter Patience Cory, 5 lb, (paid by her brother William), a cow and a feather bed. To daughter Mary Cory a cow. To daughter Amey Cory, a cow, and a bed in room called Margaret's room. To daughter Sarah Cory, 5 lb and a bed. To Four daughters, the rest of movables, when they are eighteen or married.
- iv. Thomas (Mar 2 1692. Thomas was an Inhabitant at organization of Tiverton, RI). Born, circa 1661, in Portsmouth, Newport Co RI. Died, 21 Mar 1727/8, in Tiverton, Newport Co RI. He married TABOR Sarah (Daughter of Philip and Mary (Cooke) Tabor).
Will of Thomas Corey (1661-1738) Will dated 23 September 1734.. Proved 21 March 1738. Exs. sons William and Philip. To eldest son William, half of 120 acres in Pocasset, half of swamp lot and half of 60 acre lot, supposed to have been given him in his grandfathers entail, which I confirm, also other land. To my grandson Thomas Cory, son of Thomas, of Dartmouth, deceased, 200 acres and housing, being homestead farm where my son Thomas lived, in Dartmouth, also 40 acres joining my brother in law Philip Taber's, all to be at his age. To son Philip, homestead where I now live, in Tiverton, 120 acres and housing, two cows, and young cattle already in his hands, and half the sheep and profit of house and land given to grandson John, till said grandson is of age, Philip to bring John up to learning, till sixteen and then put him to trade. To daughter Patience Cory, 250 lbs in household goods, in consideration of what my other two daughters have already had, and of her present weakness, and also Indian boy Sam and Indian girl Dinah, till their time out. To daughter Mary Durfee, wife of Thomas, 600 lb. To daughter Sarah Brown wife of Abraham 600 lb. To daughter Patience 600 lb. To Wife Susanah 100 lb and if she happen to have a child or children, he or they to have lands in Tiverton and Dartmouth not given. To son Philip, cart, plow etc. To all children, rest of personal. To daughter Patience, house room firewood and keep of cow etc. , till marriage, and ridding beast, all kept by son Philip. Inventory. 4,862 lbs 15s 6d, viz: house apparel and books 41 lb 3s 6d, pewter, 6 silver spoons, cheese press, bonds 2,955 lb 4s 2d. Neat cattle 129 lb, horse kind 26 lb, sheep 30 lb, 397 acres wild land in sundrey places, 1,165, lbs 10s
- v. Mercy. Born, circa 1662 (??) in Portsmouth, Newport Co RI. Died, circa 1727 (?), in Portsmouth, Newport Co RI. She married, first, JONES CORNELIUS, circa 1693 (?), in Providence, Providence CO RI. She married, second, CONSALLES CHARLES, 17 Nov 1704 (?), in Portsmouth, Newport Co RI.
- vi. Margaret. Born, circa 1668 (??) in Tiverton, Newport Co RI. Died, circa 1670 (??).
- vii. Mary. Born, circa 1670 (??) in Tiverton, Newport Co RI. Died, circa 1726 (??). She married COOK Thomas (Son of John and Mary (Borden) Cook), circa 1690 (??).
- viii. Caleb. Born, circa 1672 (??) in Dartmouth, Bristol Co MA. Died, circa 1704 (??). He married CORY SARAH, circa 1687 (??). 10 April 1704.. Inventory. 212 lbs 11s 4d, shown by widow Sarah, administratrix. Home and land 140 lb, wearing clothes, loom, 2 wheels, carts, gun, powder, money 1 lb 4d, 18 sheep, 6 swine 6 cows, 4 heifers, steer, 2 yearlings, mare, colts, etc
- ix. Roger. Born, circa 1675 (??) in Tiverton, Newport Co RI. Died, circa 1754 (??) in Tiverton, Newport Co RI. He married, first, an unknown woman. He married, second, DYE REMEMBRANCE ((Potter) Widow of John Dye of Little Compton, RI), 1 May 1718 (??). Jan 6, 1753. Will-- Proved 3 June 1754 Exs Rememberance and son Thomas. To eldest son William, of Tiverton 5s., and all my lands in Tiverton for life, and then to my daughters Patience, Deliverance, Sarah, Rosanna, and Content, the last having a double share, and to live with son William for life. To second son Caleb, of Tiverton, 5s and a like amount to third son Roger and fourth son Thomas, of Tiverton and fifth son Samuel, of Richmond. To wife Rememberance, all movable estate. Inventory, L302, 19s., viz: wearing apparel L26 15s., pewter, feather bed, 2 old wheels, warming pan, cow, calf, etc., bonds L59, 6s. 6d.
- x. Joan. Born, circa 1675 (??) in Tiverton, Newport Co RI. Died, circa 1754 (??). She married TAYLOR ----, circa 1795 (??).
